French for the Future requests that families discuss potential challenges with their children and find strategies to ensure their safety and success while in the United Bilingual Correspondents program.

Strategies may include:

- Communicating by text or email instead of on social media;
- Following age restrictions on websites (children under 13 shouldn't communicate through Facebook);
- Keeping social media profiles on private;
- Using applications where messages can't be deleted;
- Letting trusted adults know if anything causes participants to be uncomfortable.
